

# COST-SHARE PROGRAMS & FINANCIAL INCENTIVES FOR VIRGINIA




Below are some programs that provide technical assistance and financial incentives for approved conservation practices. All programs are voluntary. When inquiring, ask how a conservation easement applies. Agency contact information is in this packet.

<u>Conservation Practice</u>: Land practice that enhances or protects water quality, soils, and wildlife habitat. May include installing pollinator habitat or managing land with a Conservation Plan.

**Best Management Practice (BMP):** one or a combination of practices that are effective and practicable in reducing or preventing the amount of pollution that runs off from land into nearby waterways.

Not only do BMPs protect water quality and promote wildlife habitat, but they often also increase land productivity by conserving soil, making wise use of fertilizers, lowering disease rates for livestock, and providing habitat for wildlife, fish, and game.





## **Virginia Department of Forestry**

#### Pine bark beetle prevention program

Provides landowners with financial incentives to conduct pine thinnings and/or longleaf pine restoration on appropriate sites to reduce the occurrence and impact of bark beetle outbreaks.

#### Riparian forest buffer tax credit

Provides an incentive to landowners through a tax credit for preserving riparian forest buffers along waterways during a timber harvest operation.

#### **Environmental Quality Incentives Program (EQIP)**

Provides financial and technical assistance to agricultural producers to plan and implement conservation practices that improve soil, water, plant, animal, air and related natural resources on agricultural land and non-industrial private forestland.

#### **Conservation Stewardship Program (CSP)**

Provides payments to qualifying participants that take additional steps to improve resource condition including soil quality, water quality, water quality, air quality, habitat quality, or energy.

#### Socially Disdayantaged, Limited Resource, Beginning Farmers, Veteran Farmers

Provides for voluntary participation, offers incentives, and focuses on equity in accessing USDA programs and services. Enhancements include streamlined delivery of technical and financial assistance; improved programs and services; and flexibility in decision-making.

### Virginia's Soil and Water Conservation District

#### **Conservation Reserve Enhancement Program (CREP)**

Pays farmers to turn floodplains and creek banks into buffers of trees, shrubs, or native grasses.

#### **Agricultural BMP Cost-Share (VACS) Program**

The cost-share program supports the use of various practices in conservation planning to treat cropland, pastureland, hay land and forested land. Some are paid for at a flat rate or straight per-acre rate while others are cost-shared. In some cases, the United States Department of Agriculture (USDA) also pays a percentage. #### **BMP Tax Credit Program**

Agricultural producers with a conservation plan and installed Best Management Practices (BMP's) that are approved by the Soil and Water Conservation District may result in cost-share payments or a tax credit approval letter from their local SWCD.
